Policy Programme

The Charity agreed three major medium term projects to be put at the heart of its strategy to fulfil its objectives, and agreed, along with improving the operational activities taken over (and due to be taken over), from the English Bridge Union would be priorities for investment and further fund raising. These programmes cover the promotion of duplicate bridge in schools, the development of an accelerated teaching programme to make learning duplicate bridge easier for all ages, and a scientific study to look at the potential benefits of playing duplicate bridge, which itself might underpin further fund raising.

Achievements and performance

- All three projects in the agreed programme were scoped during the year with the aim of all three being launched in 2015/6.
- A major charitable donation was received the South Bucks Bridge Centre (SBBC), a profitable operation, valued at £60,403. SBBC can not only provide funds for the charity through its operations, but can be used as a test centre for new ideas on teaching. SBBC has been set up as an arms length subsidiary with its own Board of Directors, appointed by the Charity.
- A number of welcome improvements were made in the education services (see Section C) provided to players (new players and improvers) and officials playing and controlling duplicate bridge.
- Overall ,duplicate bridge operates in a competitive market for sports, and mind sports in particular; the charity is determined to ensure that the benefits of the game are well understood by potential players, that learning the game becomes as painless as possible, and that everyone has the opportunity to learn and play the game.
